Federal Surplus Property (Surplus Services) and the National Association of State Agencies for Surplus Property (NASASP) dedicated to the pursuit of obtaining Federal surplus personal property for local programs like yours. We know that budgets are tight. We know that you, like many local governments, schools, non-profit organizations, and volunteer emergency services, are scrambling to meet the ever-increasing needs of your constituents in spite of ever-decreasing resources to meet those needs.
