Federal Surplus Property (Surplus Services) and the National Association of State Agencies for Surplus Property (NASASP) dedicated to the pursuit of obtaining Federal surplus personal property for local programs like yours. We know that budgets are tight. We know that you, like many local governments, schools, non-profit organizations, and volunteer emergency services, are scrambling to meet the ever-increasing needs of your constituents in spite of ever-decreasing resources to meet those needs. NASASP and AR FSP are here to assist you in cutting your expenses by providing surplus property at low cost.

However, we are also scrambling to meet your needs. Federal surplus property transferred to FSP Donation program has declined over the last ten years. Associate Membership dues are only \$39 annually – a small cost to ensure the continued availability of heavy equipment for your municipalities, of emergency equipment to protect the men and women who protect your community, of educational supplies to ensure that your children are prepared to enter society as productive adults.
