New Regulations Regarding Donation of HMMWV's

Beginning on October 1, 2015 the Federal Government implemented changes to the process for requesting and acquiring tactical vehicles (HMMWVs). Requests by donee organizations will now require a "Letter of Intent" and a notarized "Conditional Transfer Document". The Letter of Intent must be on the donee organization letterhead, signed by the donee official of the requesting organization. The "Letter of Intent" must contain the following information:

- A general description of the requesting agency
- **DETAILED** justification for acquiring the tactical vehicle (HMMWV)
- Number of tactical vehicles (if any) already owned
- Certifications or training to be provided on the use of the vehicle
- Whether or not a request for a similar tactical vehicle has been made with another Federal program
- Whether or not a request for any tactical vehicle has been denied in the past three (3) years and, if so why
- Has the organization been found to be in violation of a Federal Civil Rights statute or program requirement in the past three (3) years and disposition of such violation

I certify that this organization, _____, will provide appropriate training for use of the requested vehicles to all employees who may operate this equipment

I certify that the above statements are true and correct. This certification is made in accordance with and subject to the penalties of Title 18, Section 1001, the United States Code, Crime and Criminal Procedures

The Letter of Intent will be approved/disapproved by the Compliance Branch. After approval is granted, the Conditional Transfer Document will be initiated and completed by both Arkansas Federal Surplus Property personnel and the receiving donee organization. Before taking possession of the HMMWV the donee organization must have an approved Letter of Intent and notarized copy of the Conditional Transfer Document.

Applications may be submitted by fax, email, or mail.
