- Property will be donated as it becomes available.
- Property is donated on an "as is, where is" basis without warranty of any kind.
- To place a hold for one, please submit a want list request form.
- **Correction from last newsletter: Humvee's are 18 month compliance items** - meaning the agency will have additional paperwork that will need to be completed to track usage. After the property has been in-use for a complete 18 months, the agency will then own the property.

We know that budgets are tight.
